## Seeding Agreement

*It is mutually agreed that the following terms apply to Roberts County Conservation District's Seeding Program. The cost of seeding includes operator, drill and tractor.*

### Seed Drill Fee:

- \$30.00/acre 1 to 10 acres
- \$24.00 (11-49 acres)
- \$20.00 (50 + acres)
- \$75.00 setup fee
- \$300.00 minimum charge**

**A proper seedbed is firm and free of competing vegetation. Correct firmness is when an adult foot print is only slightly visible on the prepared bed prior to the seeding operation. The seedbed can be firmed, if needed by pulling a commercial or homemade packer or roller.**

**THE SITE MUST BE PROPERLY PREPARED BY THE TIME OUR OPERATOR ARRIVES TO SEED. IF THE SITE IS NOT ADEQUATELY PREPARED (**ROLLED FIRM, ROCKS PICKED, WEEDS CONTROLLED ETC.**) THE DRILL OPERATOR HAS THE AUTHORITY NOT TO DO THE SEEDING AND WILL MOVE ON TO A DIFFERENT SITE.**

We request that you be present when we start seeding. Then, if any questions arise, you will be able to discuss them with the drill operator and/or office staff. The drill operator will plant your grass strictly according to the plan and any changes must be cleared with our office **BEFORE** the planting begins. You must leave adequate access to the grass seeding site for our vehicles.

The district provides **NO GUARANTEE** of survival of the new seeding due to weather conditions, failure to control weeds, chemical residual issues, and source of seed (uncertified, operator had seed leftover seed from other grass seeding's etc.) If, for some uncontrollable reason the stand proves to be considered insufficient to USDA evaluations and the seeding is being provided cost share through an official USDA program, they may re-evaluate and consider re-cost sharing if deems adequate.

A bill will be prepared after the drilling has been completed. This bill will reflect the amount due. All sums are immediately due and payable upon receipt of the bill. A finance charge will be applied after 30 days at a rate of 2.0% of the balance.

**Any bills in question will be decided upon by the Conservation District Board at their next scheduled board meeting.**
